## FENCE PERMIT SUPPLEMENT

## FENCE REGULATIONS

- FENCES SHALL BE LOCATED ONLY ON PRIVATE PROPERTY BUILT WITH CONSENT OF THE PROPERTY OWNER.
- FENCES IN FRONT YARDS CANNOT EXCEED 72" IN HEIGHT.
- FENCES IN FRONT YARDS OVER 48 " CAN ONLY BE CHAIN LINK TO NOT OBSTRUCT VIEW.
- FENCES SHALL BE LOCATED AT 5' FROM STREET OR PUBLIC RIGHT-OF-WAY.
- NO FENCE SHALL BE LOCATED WITHIN A SIGHT TRIANGLE.
- IN THE CASE OF FENCES CONSTRUCTED OVER DEDICATED UTILITY EASEMENTS, A GATE SHALL BE INSTALLED ON EACH END THE WIDTH OF THE EASEMENT. THE CITY SHALL NOT BE RESPONSIBLE FOR REPLACEMENT IF THE FENCE IS REMOVED FOR MAINTENANCE PURPOSES.
- FENCES SHALL NOT BE LOCATED IN THE PLATTED DRAINAGE EASEMENT.
- FENCE HEIGHT CANNOT EXCEED EIGHT (8) FEET ABOVE THE GROUND.
- FINISHED SURFACES SHALL FACE OUTWARDS FROM THE PROPERTY (WHERE FRONTING PUBLIC RIGHT-OFWAY).
- FENCES SHALL BE MAINTAINED IN A SAFE MANNER AT ALL TIMES.
- THIS ORDINANCE IS PASSED NOT WITH STANDING THE FACT THAT THERE IS CURRENTLY FENCES IN EXISTENCE AT PROPERTIES WHICH THEY WILL BE ALLOWED TO KEEP.
- IT IS PROVIDED, HOWEVER, THAT EXISTING FENCES SHALL NOT BE EXPANDED.
